ABSTRACT

This user's guide describes the characteristics, operation, and use of the Texas Instruments TPS51383 and TPS51384 evaluation modules (EVM). The TPS51383EVM and TPS51384EVM are designed to help user easily evaluate and test the operation and functionality of the TPS51383 and TPS51384. This user's guide includes the following:

1 Introduction

The TPS51383 and TPS51384 are the single, D-CAP3^M mode, synchronous buck converters requiring a very low external component count. The TPS51383 provides a fixed 3.36-V 8-A maximum output along with a separate 3.3-V, 100-mA maximum LDO. The TPS51384 provides a fixed 1.82-V 8-A maximum output along with a separate 1.8-V, 100-mA maximum LDO. Both support switch-over functionality, specifically designed for a notebook power system. Their integrated low R_{DS(ON)} power MOSFETs enable high efficiency and offer ease-of-use with a minimal external component count for space-constrained power systems. Features include the following:

- Accurate reference voltage
- · Fast load transient response
- · Auto-skip mode operation for light load efficiency
- OOA light load operation with > 25-kHz switching frequency
- D-CAP3 control mode with good line, load regulation, and no requirement for external compensation

The TPS51383 and TPS51384 evaluation modules (EVM) are single, synchronous buck converter boards providing 3.36 V or 1.82 V at 8 A from a 4.5-V to 24-V input. This user's guide describes the TPS51383 and TPS51384 EVM performance.

3 External Components

The TPS51383 and TPS51384 are fixed output devices. Users do not need to add feedback resistors, which saves the BOM costs and solution size. Regarding external components selection, users can refer to the following table for some recommendation values.

4 Test Setup and Results

This section describes how to properly connect, set up, and use the TPS51383EVM and TPS51384EVM. The section also includes test results typical for the evaluation modules.

4.1 Input and Output Connections

The TPS51383EVM and TPS51383EVM are provided with input and output connectors and test points as shown in the following table. A power supply capable of supplying 8 A must be connected to J1 through a pair of 20AWG wires. The load must be connected to J2 through a pair of 20AWG wires. The maximum load current capability is 8 A. Wire lengths must be minimized to reduce losses in the wires. Test point TP2 provides a place to monitor the V_{IN} input voltages with TP9 providing a convenient ground reference. TP5 is used to monitor the output voltage with TP12 as the ground reference.




4.2 Start-Up Procedure

- Ensure that the jumper at JP2 (Enable High Control) is covered to connect V_{IN} to pin 1 of JP3. Also ensure JP3 (Enable Control) pin 2 and 3 are covered to shunt EN to GND to disable the output.
- 2. Apply appropriate input voltage to VIN (J1-1) or TP1 and GND (J1-2) or TP8. Note that the board cannot support hot plug-in. The input lines must be connected between J1 and external power source first before turning on the power source.
- 3. Move the jumper at JP3 (Enable Control) from pin 2 and 3 (EN and OFF) to pin 2 and 1 (EN and ON). Make sure JP3 pin 1 and pin 2 are covered, then the output can be enabled.
- 4. Apply the loading to VOUT (J2-2) or TP4 and GND (J2-1) or TP10.






Figure 4-2. TPS51384EVM Start-Up Relative to EN, I_{OUT} = 0.1 A





Figure 4-4. TPS51384EVM Shutdown Relative to EN, I_{OUT} = 0.1 A




Figure 4-6. TPS51383EVM Output Voltage Ripple, I_{OUT} = 10 mA, OOA Mode




Figure 4-7. TPS51383EVM Output Voltage Ripple, I_{OUT} = 8 A



5 Board Layout

This section provides a description of the TPS51383 and TPS51384 EVM, board layout, and layer illustrations.

5.1 Layout

The following images show the board layout for the TPS51383EVM and TPS51384EVM. The TPS51383EVM and TPS51384EVM have four layers. The top layer contains the main power traces for VIN, VOUT, and GND. Also on the top layer are connections for the pins of the TPS51383EVM and TPS51384EVM and a large area filled with ground. Most of the signal traces are also located on the top side. The input decoupling capacitors, C3, C4, C5, and C6 are located as close to VIN pins and PGND pins of the IC as possible. The input and output connectors, test points, and all of the components are located on the top side. The bottom layer is a ground plane along with signal ground copper fill and the feedback trace from the point of regulation to the top of the resistor divider network. Two inner layers are ground plane.




Figure 5-1. TPS51383 and TPS51384 EVM Top Assembly




Figure 5-2. TPS51383 and TPS51384 EVM Top Layer






Figure 5-3. TPS51383 and TPS51384 EVM Inner1 Layer




Figure 5-4. TPS51383 and TPS51384 EVM Inner2 Layer




Figure 5-5. TPS51383 and TPS51384 EVM Bottom Layer




Figure 6-1. Top View of TPS51383EVM




Figure 6-2. Bottom View of TPS51383EVM




Figure 6-3. TPS51383EVM Schematic Diagram




Figure 6-4. TPS51384EVM Schematic Diagram
