

LM76202-Q1 Evaluation Module

This user's guide describes the evaluation module (EVM) for the Texas instruments LM76202-Q1 and LM74202-Q1 Ideal diodes. The document provides EVM configuration information and test setup details for evaluating the LM76202-Q1 or LM74202-Q1 device. The EVM schematic, board layout and bill of materials (BOM) are also included.

1 Introduction

The LM76202-Q1EVM allows reference circuit evaluation of TI's LM76202-Q1 and LM74202-Q1 ideal diodes. The LM76202-Q1 device is 4.5 V to 5560 V, 2.23-A ideal diode with reverse battery protection, overvoltage, short-circuit and reverse current blocking protection. The LM74202-Q1 device is 4.5 V to 40 V, 2.23-A ideal diode with reverse battery protection, overvoltage, short-circuit and reverse current blocking protection.

1.1 EVM Features

LM76202-Q1EVM features include:

- 4.2-V to 60-V Operating voltage (without TVS on Input)
- 4.2-V to 33-V (with 33-V TVS on input for transient protection)
- 0.2 A to 2.23 A programmable current limit using onboard jumpers
- MODE pin configuration using onboard jumpers
- Output overvoltage protection (34 V)
- Load protection from transients: ISO 7637-2 Pulse 1 and ISO 16750-2 Pulse 5b
- UVLO configuration using onboard jumpers
- LED status indication for $\overline{\text{FLT}}$ output and VOUT

- Automotive ECU protection
- Camera supply protection
- Telematics
- Industrial transport

2 Description

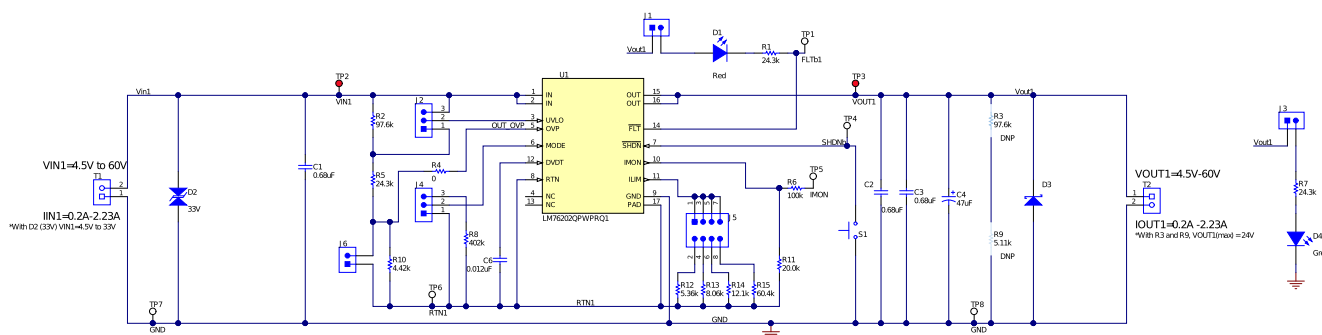
The LM76202-Q1EVM enables evaluation of LM76202-Q1 and LM74202-Q1 ideal diodes. [Table 1](#) provides the operating range and jumper settings for this EVM. To test this EVM, setup the EVM as per steps provided in [Section 5.5](#). Test procedure and results for this EVM are provided in [Section 6](#). To configure the EVM for another configuration (non-default), see [Table 4](#). To probe different signals on this EVM, see [Table 3](#). Equipments required to test this EVM are listed in [Section 5](#). To connect power supply and load to this EVM, see [Section 4.1](#).

4.1 Input and Output Connector Description

5 Test Equipment and Setup

5.1 Power Supplies

One adjustable power supply 0-V to 60-V output, 0-A to 10-A output current limit. UCS 200N and LD 200N for generating transient voltages as per ISO 7637-2 and ISO 16750-2 specifications

5.2 Meters

One DMM needed

5.3 Oscilloscope

A DPO2024 or equivalent, three 10x voltage probes, and a DC current probe

5.4 Loads

One resistive load or equivalent which can tolerate up to 10-A DC load at 60 V and capable of the output short.

5.5 Test Setup

Before performing any of the test listed in [Section 6](#), setup the EVM as per steps below:

- Make sure that jumper settings on EVM are set to default position as shown in [Table 5](#)

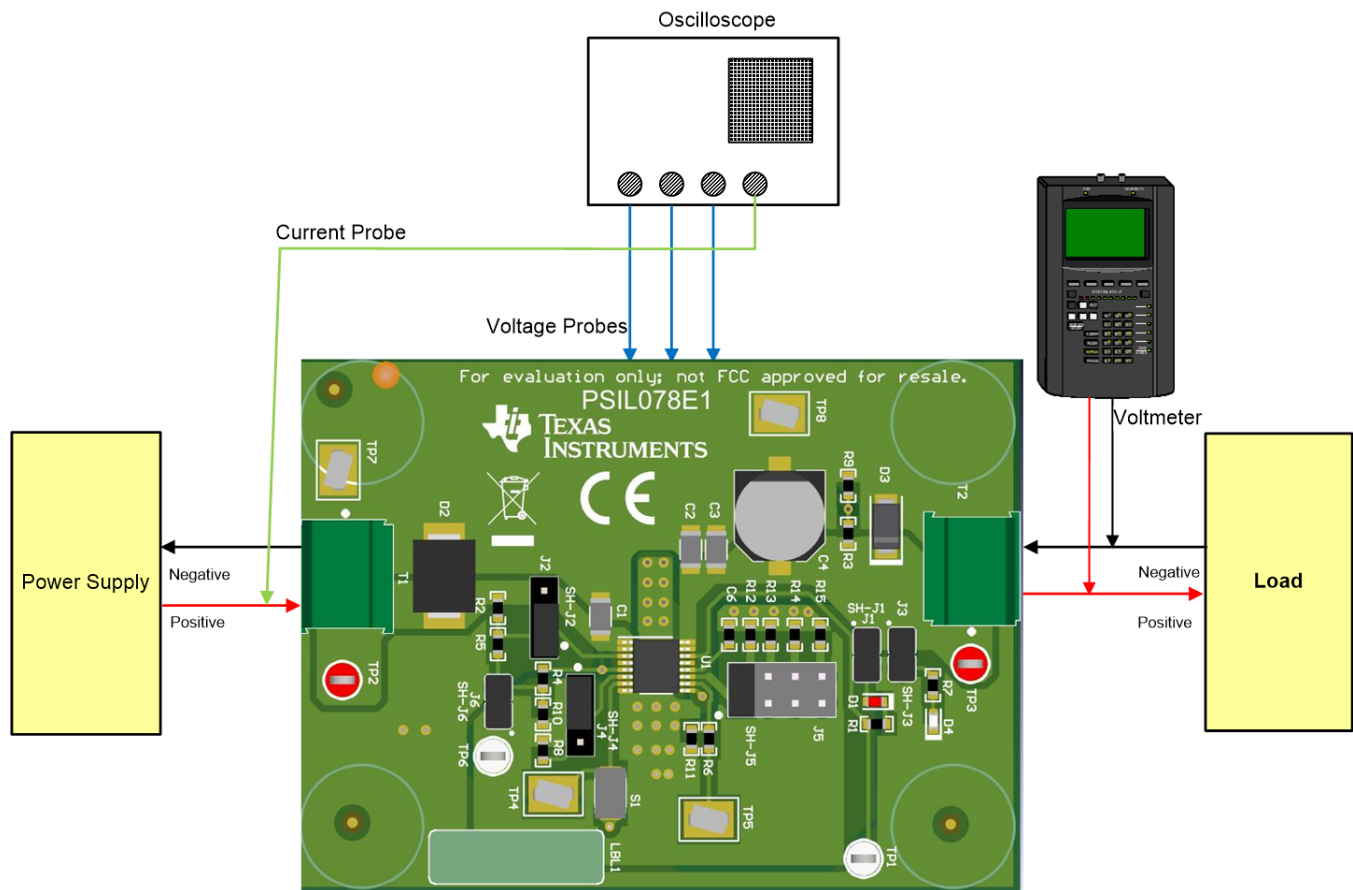


Figure 2. LM76202-Q1 EVM Setup

- Connect the power supply, load, oscilloscope and voltmeter to the EVM as shown in [Figure 2](#)
- Set the power supply output to zero volts.
- Turn ON the power supply and set the power supply output to 12.5 V and current limit to 10 A.
- Turn OFF the power supply

6 Test Procedure and Results

6.1 Hot-Plug Test

Use the following instructions to measure the output slew rate and input inrush current during Hot-Plug event.

- Set the input supply voltage V_{IN} to 12.5 V and current limit of 10 A. Enable the power supply.
- Hot-plug the supply at input connector T1.
- Observe the waveform at V_{IN} , V_{OUT} , \overline{FLT} and I_{IN} with an oscilloscope to measure the output slew rate and rise time .

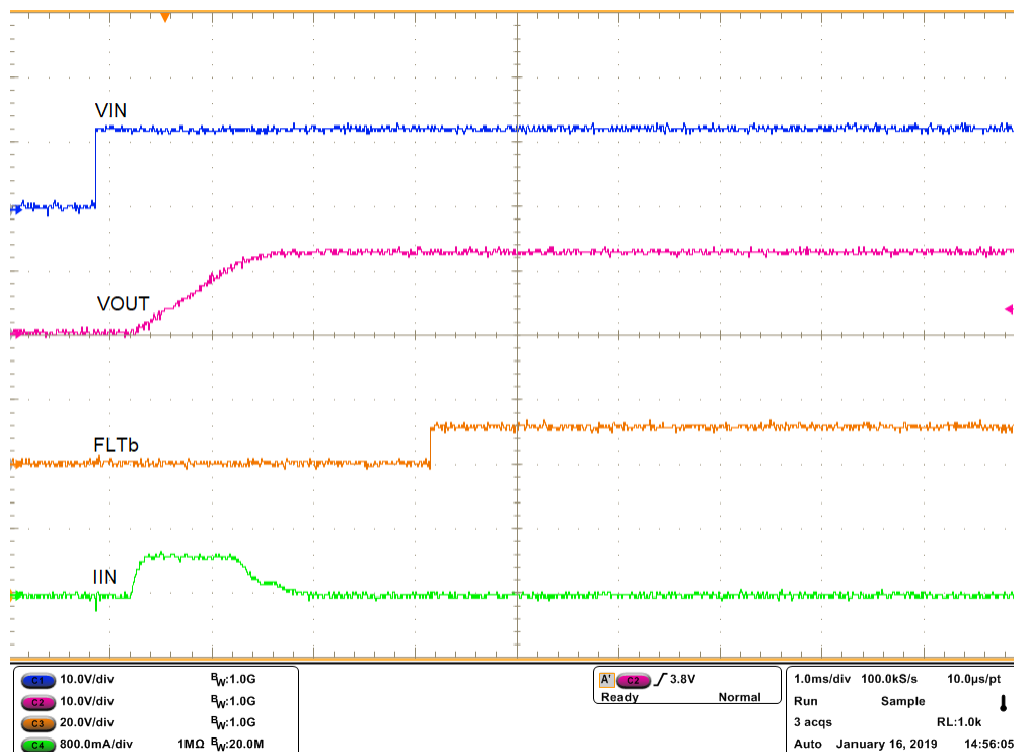


Figure 3. LM76202-Q1EVM Output Slew Rate with Inrush Current Limiting ($V_{IN} = 12.5\text{ V}$, $C_{dVdT} = 12\text{ nF}$, $C_{OUT} = 47\text{ }\mu\text{F}$, No-load)

Figure 3 shows an example of inrush current captured on the LM76202-Q1EVM.

6.2 Current Limit Test

Use the following instructions to perform current limit test.

- Set the input supply voltage V_{IN} to 12.5 V and current limit of 10 A and enable the power supply.
- Connect the power supply on connector T1 of the EVM.
- By default, the EVM is configured for 2.23 A current limit.
- Connect a load of 3 Ω (20 W) at connector T2 of the EVM.
- The device limits the current to 2.23 A, turns off the internal MOSFET after reaching the thermal shutdown temperature (TSD) and auto-retries after a time of t_{retry} (512 ms)

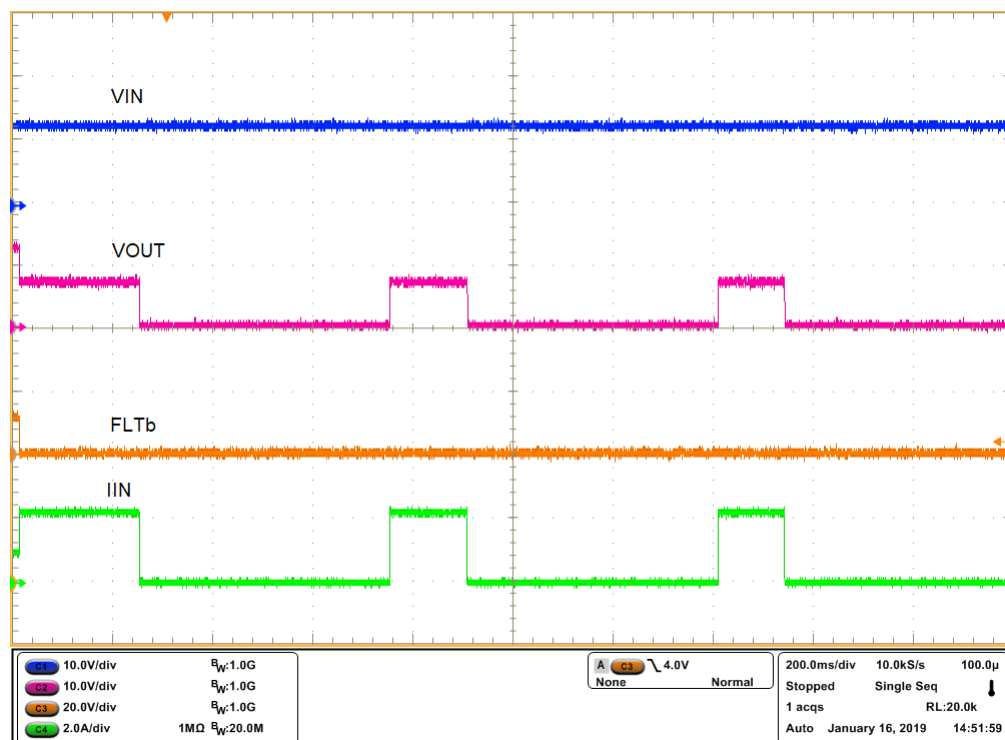


Figure 4. LM76202-Q1EVM Current Limit Operation ($V_{IN} = 12.5\text{ V}$, $I_{LIM} = 2.23\text{ A}$, $R_{OUT} = 3\ \Omega$, $MODE = RTN$)

Figure 4 shows an example of current limit at 2.23 A on the LM76202-Q1EVM

6.3 Output Hot-Short Test

Use the following instructions to perform output Hot-Short test

- Set the input supply voltage V_{IN} to 12.5 V and current limit of 10 A and enable the power supply.
- Short the output of the device on connector T2, V_{OUT} to GND with a short and thick wire (5cm long and 4 sq. mm thick).
- Observe the waveforms of V_{IN} , V_{OUT} , \overline{FLT} and I_{IN} using an oscilloscope.

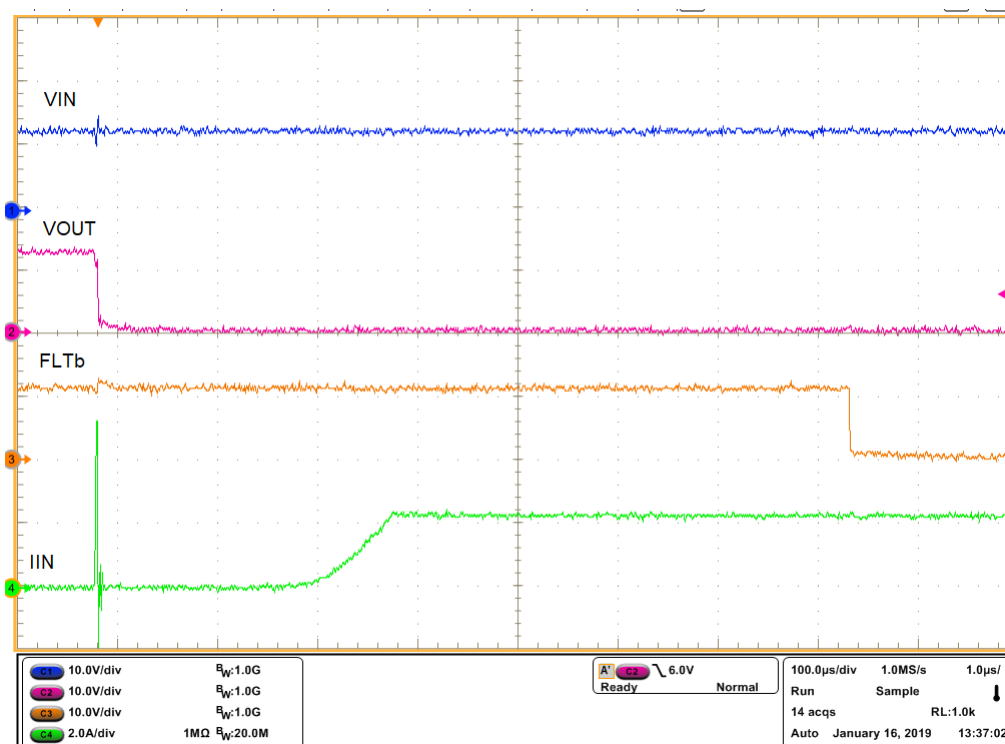


Figure 5. LM76202-Q1EVM Output Hot Short ($V_{IN} = 12.5\text{ V}$, $I_{LIM} = 2.23\text{ A}$, $MODE = RTN$)

Figure 5 shows an example of output hot short on the LM76202-Q1EVM. \overline{FLT} is pulled-up from V_{IN} for this test.

6.4 Overvoltage Cut-off Protection Test

Use the following instructions to perform output overvoltage protection test

- Set the input supply voltage V_{IN} to 36 V and current limit of 10 A and enable the power supply.
- Connect a load of $28\ \Omega$ (30 W) at connector T2 of the EVM.
- Observe the waveforms of V_{IN} , V_{OUT} , \overline{FLT} and I_{OUT} using an oscilloscope.

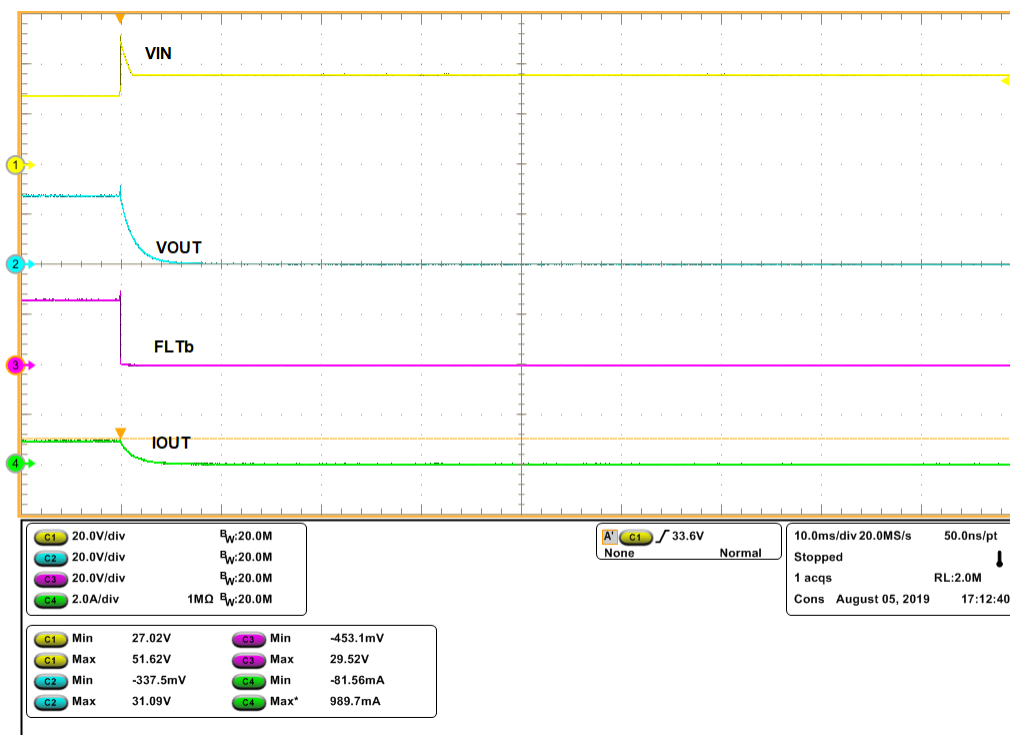


Figure 6. LM76202-Q1EVM Output Overvoltage Protection ($V_{IN} = 36\text{ V}$, $I_{LIM} = 2.23\text{ A}$, $R_{OUT} = 28\ \Omega$, $MODE = RTN$)

Figure 6 shows an example of overvoltage cutoff protection on the LM76202-Q1EVM. \overline{FLT} is pulled-up from V_{IN} for this test.

6.5 Wake-up Into Short Test

Use the following instructions to perform Wake-up into Short test

- Set the input supply voltage V_{IN} to 12.5 V and current limit of 10 A and enable the power supply.
- Short the output of the device on connector T2, V_{OUT} to GND with a short and thick wire (5cm long and 4 sq. mm thick).
- Observe the waveforms of V_{IN} , V_{OUT} , \overline{FLT} and I_{IN} using an oscilloscope.

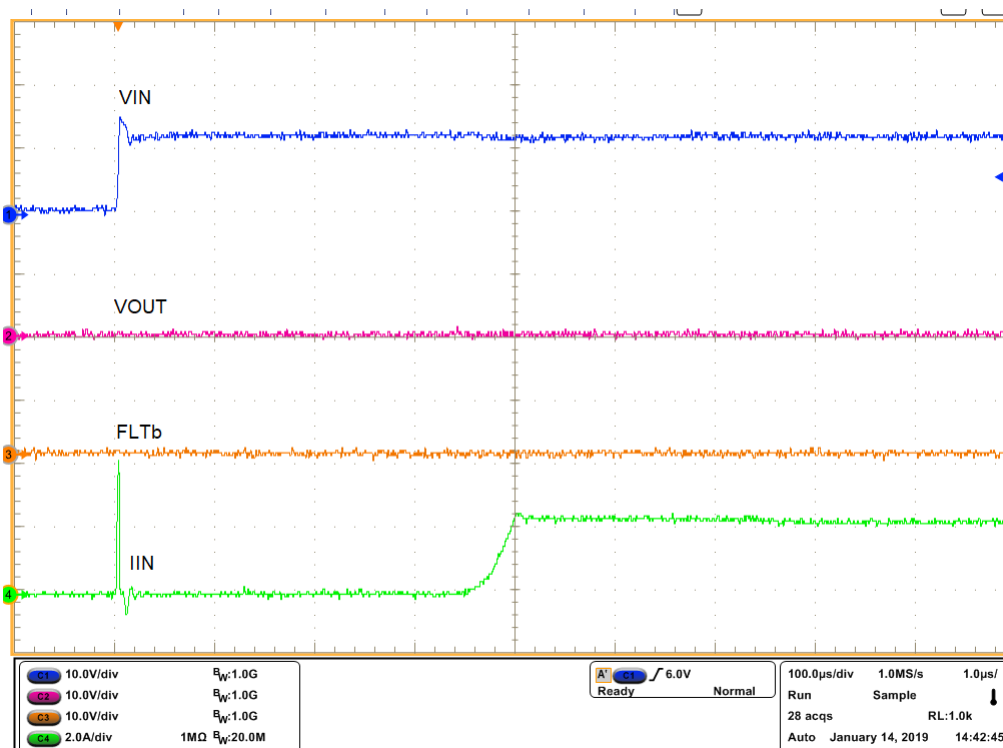


Figure 7. LM76202-Q1EVM Wake-up Into Short (VIN = 12.5 V, ILIM = 2.23 A, MODE = RTN)

Figure 7 shows an example of Wake-up into Short on the LM76202-Q1EVM. \overline{FLT} is pulled-up from V_{OUT} for this test.

6.6 Negative Input Voltage Transient Test (ISO 7637-2 Pulse 1)

Use the following instructions to perform negative input voltage transient test

- Select the ISO 7637-2 Pulse 1 in UCS 200N simulator.
- Set the parameters for pulse as:
 - Battery voltage = 12 V
 - $U_s = -150$ V
 - $R_i = 10 \Omega$
 - $t_r = 1 \mu s$
 - $t_1 = 0.5$ s
 - $t_2 = 200$ ms
- Connect the output of UCS 200N to input connector T1 of the EVM.
- Connect a load of 12Ω on the output connector T2 of the EVM.
- Enable the output of UCS 200N and start the test.
- Observe the waveforms of VIN, VOUT and IOU using an oscilloscope.

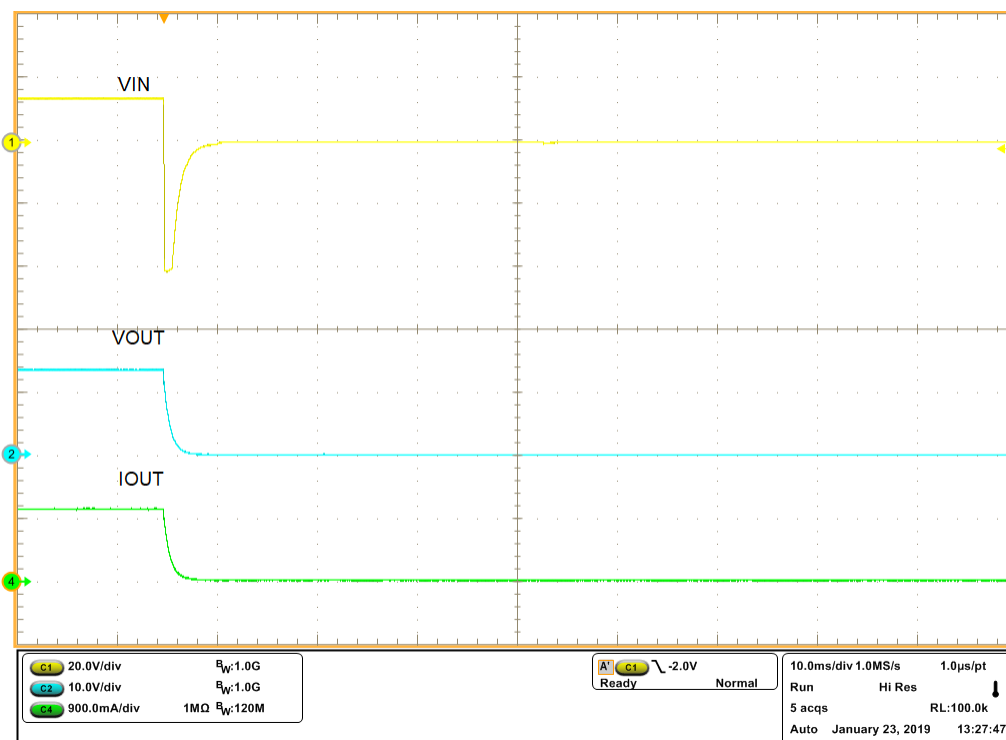


Figure 8. LM76202-Q1EVM Negative Input Voltage Transient Test (12-V battery voltage, transient voltage = -150 V , $R_{LOAD} = 12 \Omega$)

Figure 8 shows the protection of load during a negative input voltage transient of -150 V (with specifications as per ISO 7637-2 pulse 1). The TVS diode D2 clamps the input voltage to -40 V during the transient event.

6.7 Positive Input Voltage Transient Test (ISO 16750-2 Pulse 5b)

Use the following instructions to perform positive input voltage transient test

- Select the ISO 16750-2 Pulse 5b in LD 200N simulator.
- Set the parameters for pulse as:
 - U_s or $V_p = 21 \text{ V}$
 - $R_i = 0.5 \Omega$
 - $t_r = 5 \text{ ms}$
 - $t_1 = 60 \text{ s}$
 - $t_d = 100 \text{ ms}$
- Connect the output of LD 200N to input connector T1 of the EVM.
- Connect a load of 14Ω on the output connector T2 of the EVM.
- Enable the output of LD 200N and start the test.
- Observe the waveforms of VIN, VOUT and IOUT using an oscilloscope

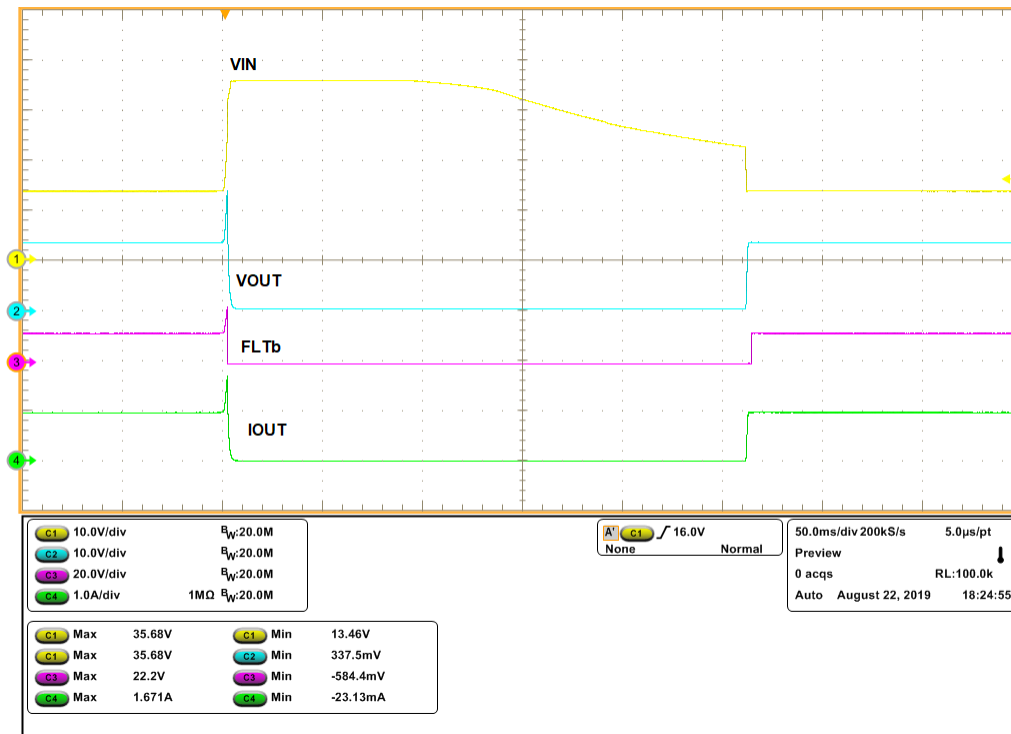
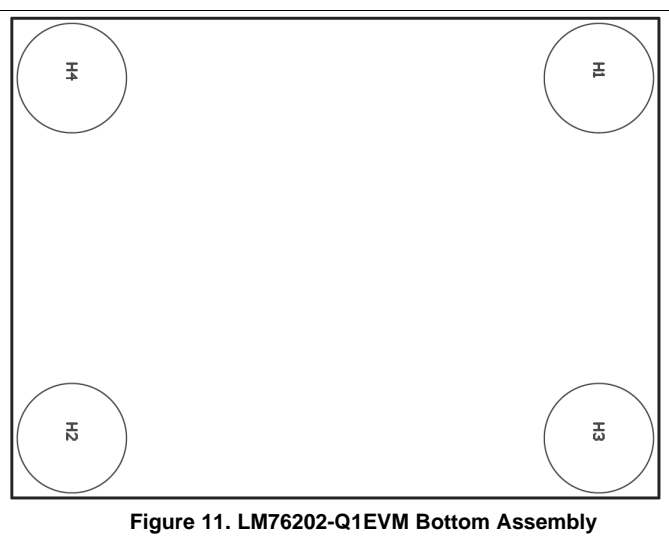
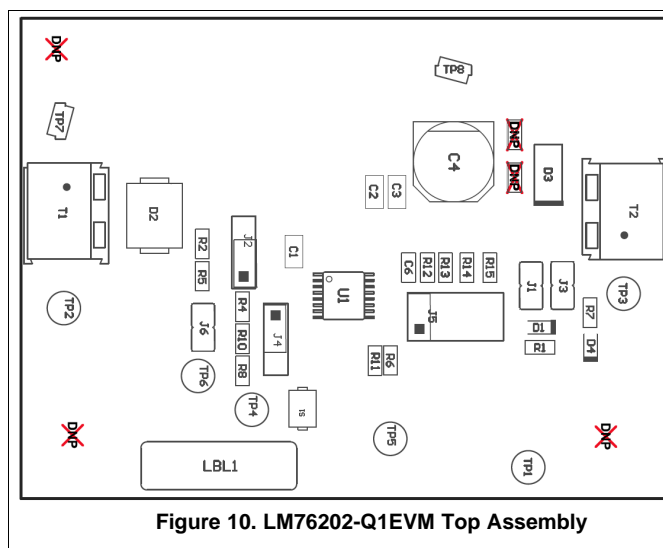


Figure 9. LM76202-Q1EVM Positive Input Voltage Transient Test (12-V battery voltage, transient voltage = 36 V , $R_{LOAD} = 14 \Omega$)

Figure 9 shows the protection of load during a positive input voltage transient of 36 V (with specifications as per ISO 16750-2 pulse 5b) . The output is cut off from input during the transient and it returns to nominal value after the transient.

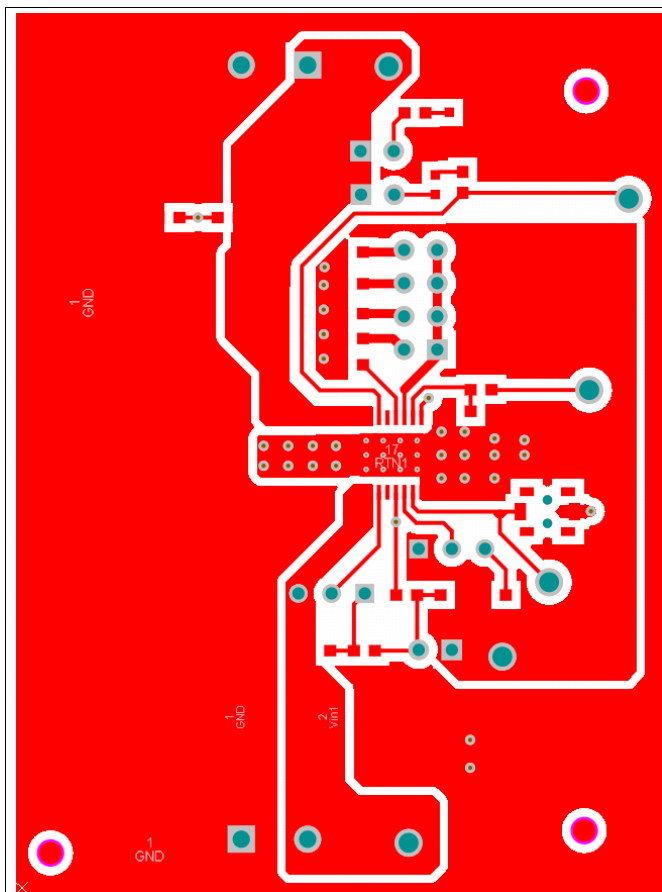


Figure 12. LM76202-Q1EVM Top Layer

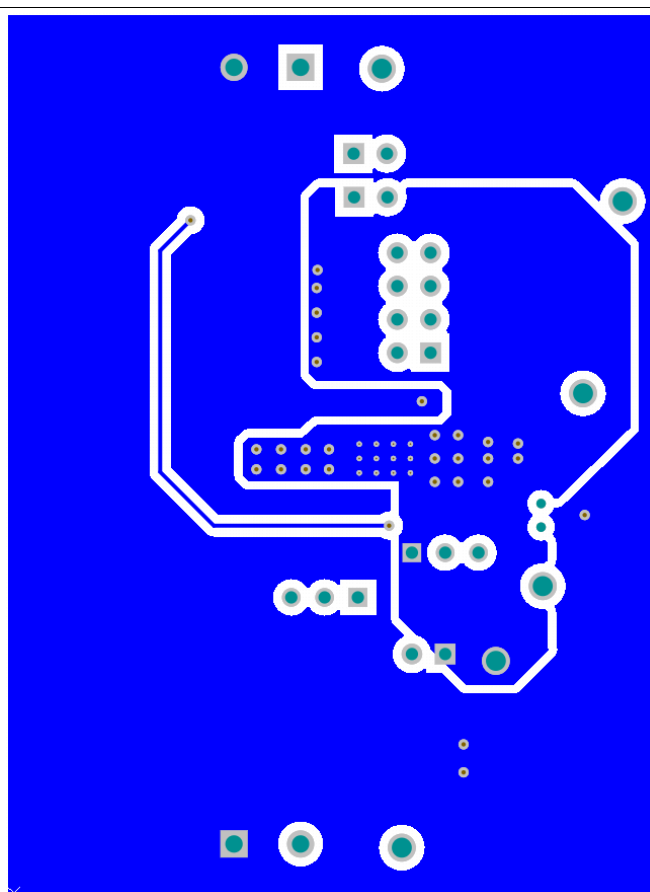


Figure 13. LM76202-Q1EVM Bottom Layer

Figure 10 and Figure 11 show component placement of the EVM Board. Figure 12 and Figure 13 show PCB layout for top and bottom layers of the EVM.
