## Introduction

The Texas Instruments LM75AEVM evaluation module (EVM) helps designers evaluate the operation and performance of the LM75A. The LM75A is an industry-standard digital temperature sensor with an integrated Sigma-Delta analog-to-digital converter with a digital I<sup>2</sup>C interface. The LM75A provides 9-bit digital temperature readings with an accuracy of  $\pm 2^{\circ}\text{C}$  from  $-25^{\circ}\text{C}$  to  $100^{\circ}\text{C}$  and  $\pm 3^{\circ}\text{C}$  from  $-55^{\circ}\text{C}$  to  $125^{\circ}\text{C}$ . It has an Over-temperature Shutdown (O.S.) pin that can be used in Comparator or Interrupt mode.

The EVM contains one LM75A digital temperature sensor. It comes pre-assembled with the LM75A, and the jumper header allows the end user to select the desired slave ID address on board. The EVM kit includes a USB2ANY interface board. The evaluation board communicates through the MSP430 microcontroller using the USB2ANY interface board to provide I<sup>2</sup>C bus. The USB2ANY interface board is used to relay the information from the EVM to USB2ANY via the PC running the LabVIEW evaluation software.



## Board Connectors and Components

This section describes the jumpers and connectors on the LM75AEVM, and how to properly connect, set up and use the LM75AEVM.

### 2.1 Input/Output Connector Description and Components

#### 2.1.1 Power Supply Input – VDD and GND

The power supply pin of the device is connected to the 3P3V jumper. The EVM does not require an external power supply. It can be powered by shorting the J2 connector from the USB2ANY interface board with a regulated voltage. There are two bypass capacitors: 10 $\mu$ F tantalum and 0.1 $\mu$ F ceramic.




Figure 2-2. VCC Jumper

### 2.1.2 Inter-IC (I<sup>2</sup>C) Bus Test Point

The standard 100 mils header allows probing of the I<sup>2</sup>C bus. The I<sup>2</sup>C bus requires two bus lines to communicate with the device: a serial data line (SDA) and a serial clock line (SCL). There is an additional OS, VCC, and GND that is not part of the I<sup>2</sup>C interface.

### 2.1.3 Interface Connector - J1

J1 is used to connect the LM75AEVM to the USB2ANY board. USB2ANY is the I<sup>2</sup>C protocol master control by the PC via LabVIEW software. The bundle setup is allowed accessing to the device registers and temperature data.




Figure 2-4. USB2ANY Interface Connector

### 2.1.4 Slave Address

The LM75A is connected to the bus by a unique slave address, to operate data transfer from the master-transmitter to the slave-receiver or slave-transmitter to the master-receiver. At default, this jumper is pulling high, and shorting the two terminals allow setting to a "LOW". Refer to the [LM75A datasheet](#) for more details.




Figure 2-5. I<sup>2</sup>C Slave Select Jumper



## Software Installation

The latest version of the LM75A software can be downloaded from: <http://www.ti.com/product/lm75a>. The LM75A software must be installed before connecting LM75AEVM to your PC.


To install the LM75A Software:

1. Click this link: <http://www.ti.com/product/lm75a>, scroll down to the “software” section, and download the latest LM75A evaluation software.
2. Unzip the downloaded file into a known directory, and run the “setup.exe” file located in the previously created folder. Follow the instructions on the pop-up window, and click “Next” to install the software.

3. When the installation is finished, please click the “Finish” button.

4. Before launching the LM75A software, connect USB2ANY board to a USB port of your PC. The USB2ANY interface board is recognized by the host as a generic human interface device (HID); therefore, there is no proprietary driver required to install on your PC.

## Board Setup and Operation

1. For proper operation of the LM75AEVM, J2 should be jumped. This will allow the LM75A's VDD to be sourced from an on-board 3.3V regulator.
2. Jumping J3 will allow configuration of the I<sup>2</sup>C slave address to a desired address.

The figures below show the connection between the LM75AEVM and the USB2ANY interface board module.




Figure 4-1. LM75AEVM Hardware Connection

### 4.1 Launching the Software

1. The LM75A GUI software can be run by clicking Start | All Program | Texas Instruments | LM75A. Launching the software will take you directly to the main GUI (Registers tab). The “Registers” tab contains a list of LM75A registers. It provides access to the registers of the LM75A by performing read and write commands.




Figure 4-2. Registers Tab

- The “Graphing” tab allows capturing and displaying of the temperature data. By default, the plotting will not start until the “Start” button is pressed. Click on the “Stop” button to stop the plotting. The temperature data can be saved as an excel file by right-clicking, and selecting the Export | Export Data To Excel.




Figure 4-3. Graphing Tab

3. The “Control” tab provides the user with instant monitoring capabilities and control of the device from the screen. This tab is very similar to the “Registers” tab.




Figure 4-4. Control Tab

## Board Layout

Figure 2-4, Figure 2-5, and Table 2-1 show the board layout for the LM75AEVM. The EVM offers jumpers to set the three least significant bits of the I<sup>2</sup>C slave address, in order to run the LM75AIM temperature sensor.




Figure 5-1. Top Assembly Layer
