Delivery will be made via UPS GND (shipping charges will be prepaid and invoiced at time of shipment). 3.PRICES.

Written quotations expire automatically 30 days from the date issued and are subject to adjustment on account of specifications, quantities, shipment arrangements or other terms and conditions that are not part of the original price quotation. Prices are exclusive of all excise, sales, use and other taxes imposed by any federal, state, municipal or other governmental authority, all of which taxes shall be paid by the purchaser.
