

EVM User's Guide: TPSM8287B30LAPEVM

TPSM8287B30 评估模块

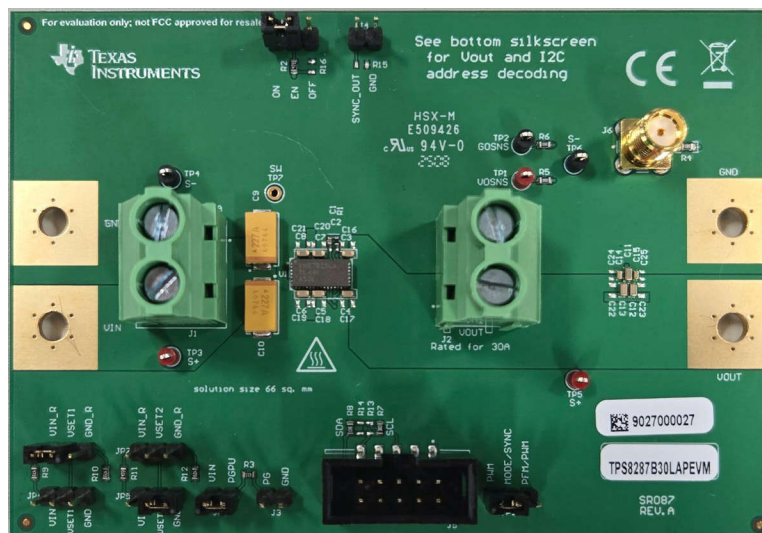


说明

TPSM8287B30LAPEVM 评估模块 (EVM) 有助于评估 TPSM8287B30。该器件是具有 I²C 接口、遥感和频率同步功能并采用 3.75mm × 8mm MagPack™ 封装的引脚对引脚兼容降压电源模块，支持高达 30A 的负载电流。这些 EVM 可提供 0.4V 至 1.675V 的 I²C 可调节输出电压，精度为 0.8%，输入电压范围为 2.7V 至 6V。

特性

- 具有集成电感器、输入电容器和输出电容器且采用 MagPack 封装的 30A 输出电流电源模块
- 出色的热性能 ($\theta_{JA} = 11.9^{\circ}\text{C/W}$)
- 3.75mm × 8mm × 2mm 电源模块的设计总尺寸为 66mm²
- 启动输出电压可通过跳线调节为 16 个值中的一个
- 具有遥感功能和可调节控制环路补偿的高精度输出电压



1 评估模块概述

1.1 简介

TPSM8287B30LAPEVM 支持在典型的独立降压转换器应用中评估 TPSM8287B30LAPVCHR 电源模块。该 EVM 还可用于评估整个 TPSM8287Bxx 系列，只需将板上的 IC 更改为目标版本即可。TPSM8287Bxx 是高效率、高精度、小尺寸电源模块，适用于 FPGA、ASIC、DSP 等内核电源应用；光学模块；存储；测试和测量以及其他空间受限型应用。

1.2 套件内容

TPSM8287B30LAPEVM 工具箱（套件）包括一个 PCB (SR087)，用于在典型的独立（非并联）应用中评估 TPSM8287B30 器件。要使用 TI 的 TPSM8287B30 EVM GUI 通过 I²C 总线来评估器件，请单独订购 [USB2ANY 适配器 EVM](#)。

1.3 规格

1.4 器件信息

TPSM8287B30 是引脚对引脚兼容的 15A、20A、25A 和 30A 电源模块系列，该系列集成了电感器以及输入和输出电容器。这些器件使用 I²C 接口微调输出电压，用于精确匹配处理器内核的需求。这些器件无需 I²C 接口即可运行，用于提供具有高电流、固定输出电压的电源。

2 硬件

2.1 安全说明

2.2 接头信息

J1 - VIN/GND	输入电源和 EVM 之间的输入和回路连接。 该连接器可使用高达 10 AWG 的导线。
MH1/2 - VIN/GND	输入电源和 EVM 之间的备用输入和回路连接。 这些孔的尺寸适合 M4 或 8 号螺栓。
J2 - VOUT/GND	从 EVM 到负载的输入和返回连接。 该连接器可使用高达 10 AWG 的导线。
MH3/4 - VOUT/GND	EVM 和负载之间的备用输入和回路连接。 这些孔的尺寸适合 M4 或 8 号螺栓。
J3 - PG/GND	该接头的引脚 2 为 PG 输出，引脚 1 接地。
J4 - SYNC_OUT/GND	该接头的引脚 1 为 SYNC_OUT 信号，引脚 2 接地。
J6 - VOUT/GND SMA	测量该 SMA 连接器处的输出电压波形。

2.3 跳线信息

JP1 - EN	EN 引脚输入跳线。使提供的跳线跨接 ON 和 EN 以开启模块。使用跳线跨接 OFF 和 EN，以便关断模块。 在 ON 和 EN 之间安装跳线后，用户就可以用 R2 和 R16 产生精确的导通电压。保持 R2 的值高于 15k Ω 。
JP2 - MODE/SYNC	MODE/SYNC 引脚输入跳线。使提供的跳线跨接 PWM (脉宽调制) 和 MODE/SYNC 以在强制 PWM 模式下运行 IC。使跳线跨接 PFM (脉冲频率调制) /PWM 和 MODE/SYNC 以在 PFM/PWM 模式下运行 IC。移除跳线以在 MODE/SYNC 引脚上应用同步信号。
JP3 - PG 上拉电压	PG 引脚上拉电压跳线。将提供的跳线置于 JP3 上，从而将 PG 引脚上拉电阻连接到 VIN。或者，可移除跳线，并在引脚 1 上施加不同电压，从而将 PG 引脚上拉到不同电平。外部施加电压必须低于 6.5V。
JP4 和 JP6 - VSET1	VSET1 设置跳线。将提供的跳线置于 JP4 或 JP6 上，但不能同时置于两者上。
JP5 和 JP7 - VSET2	VSET2 设置跳线。将提供的跳线置于 JP5 或 JP7 上，但不能同时置于两者上。

要正确设置启动电压，必须在施加 VIN 之前设置 VSETx 的两个跳线。施加 VIN 后更改跳线不会有任何影响。

施加 VIN 之前，确认两个跳线分别安装至 JP4 或 JP6 以及 JP5 或 JP7。

请勿将 VSETx 引脚悬空。

2.4 接口

J5 - I²C	I ² C 适配器连接。将 10 引脚带状电缆从 USB2ANY 适配器 EVM 连接到该接头，以便通过 TPSM8287B30 EVM GUI 经由 I ² C 总线与器件进行通信。该接头为键控式，可防止向后安装。TPSM8287B30LAPEVM 无需 USB2ANY EVM 即可运行。

2.5 测试点

TP1/2 - VOSNS/GOSNS	稳压输出电压连接。测量此处的输出电压调节。
TP3/4 - VIN/GND S+/S -	输入电压感测连接。测量此处的输入电压。
TP5/6 - VOUT/GND S+/S -	用于效率测量的输出电压检测连接。计算效率时测量此处的输出电压。
TP7 - SW	SW 节点测试点。测量此点处的 SW 节点。此测试点未安装。

3 软件

TPSM8287B30 EVM GUI 位于 [TPSM8287B30LAPEVM](#) 工具文件夹，可通过 USB2ANY 适配器 EVM 经由 I²C 总线与器件进行通信。必须施加有效的输入电压。

GUI 将自动连接到 EVM。如果未自动连接，则点击 GUI 右上角的 [连接](#) 按钮或 GUI 左下角的 [链接](#) 符号。

4 实现结果

TPSM8287B30LAPEVM 用于采集 [TPSM8287Bxx 2.7V 至 6V 输入、15A、20A、25A 和 30A、可并联降压电源模块 \(带 I²C 接口和远程感测\) \(MagPack™ 封装\)](#) 数据表中的所有数据。有关此 EVM 的性能，请参阅器件数据表。

4.1 评估设置

4.1.1 纹波测量设置

SMA 连接器 J6 用于测量输出电压纹波和瞬态响应。为获得出色效果，请使用同轴电缆 (而不是使用 10x 示波器探头) 将 SMA 连接器直接连接到示波器。该操作允许在示波器上设置 V/div 最小值以查看纹波。该 EVM 包含一个与 SMA 连接器串联的 49.9 Ω 电阻，用于阻挡同轴电缆上的反射。可以使用示波器上的高阻抗或 50 Ω 端接设置。

4.1.2 环路响应测量

将 R5 替换成 10 Ω 电阻并在两端施加注入信号，即可测量环路响应。[图 4-2](#) 展示了环路响应测量结果。

4.1.3 精确的导通电压

安装 JP1 上的跳线后，可以修改 R2 和 R16 以产生精确的导通电压。有关详细信息，请参阅 [使用带有精密使能引脚阈值的直流/直流转换器实现零噪声启动](#) 模拟设计期刊。保持 R2 的值高于 15k Ω 。

4.2 性能数据和结果

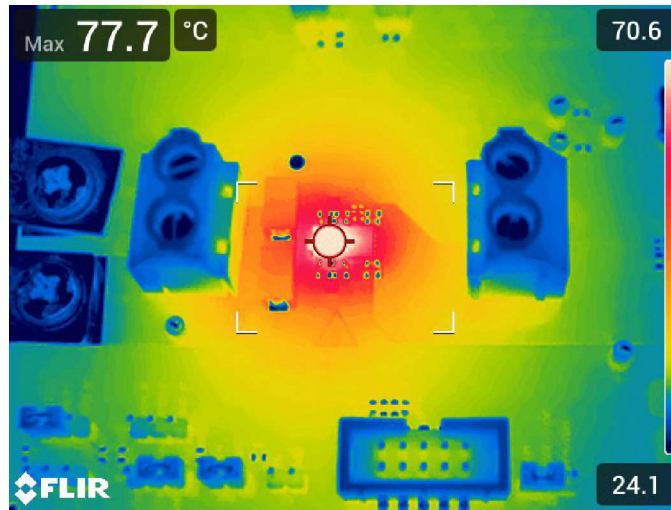

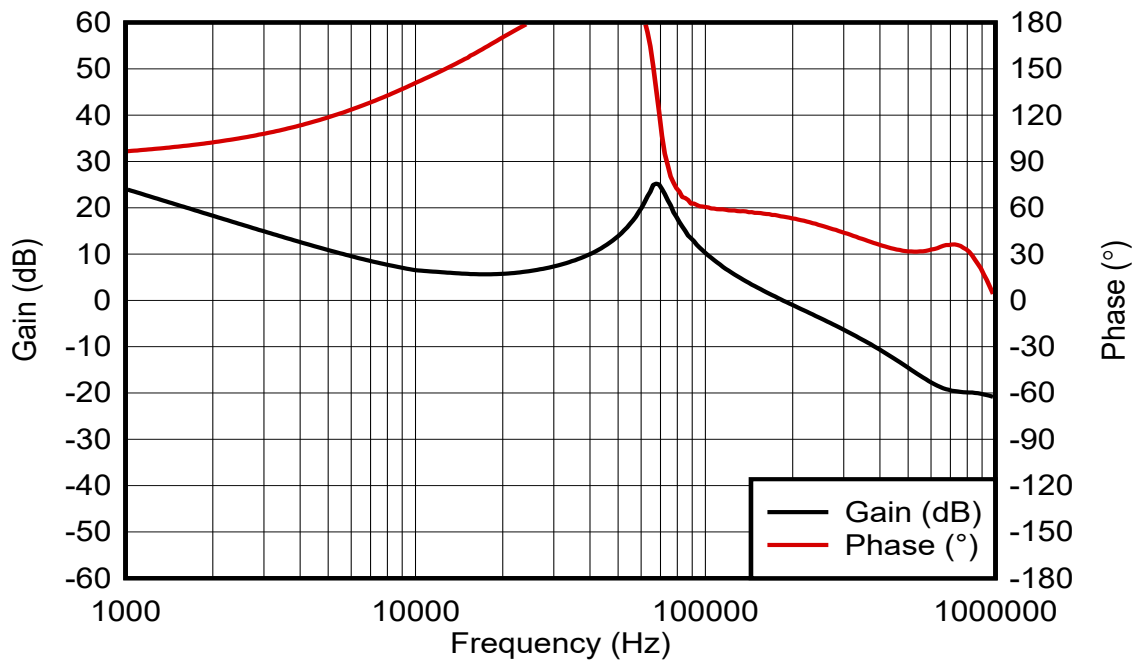

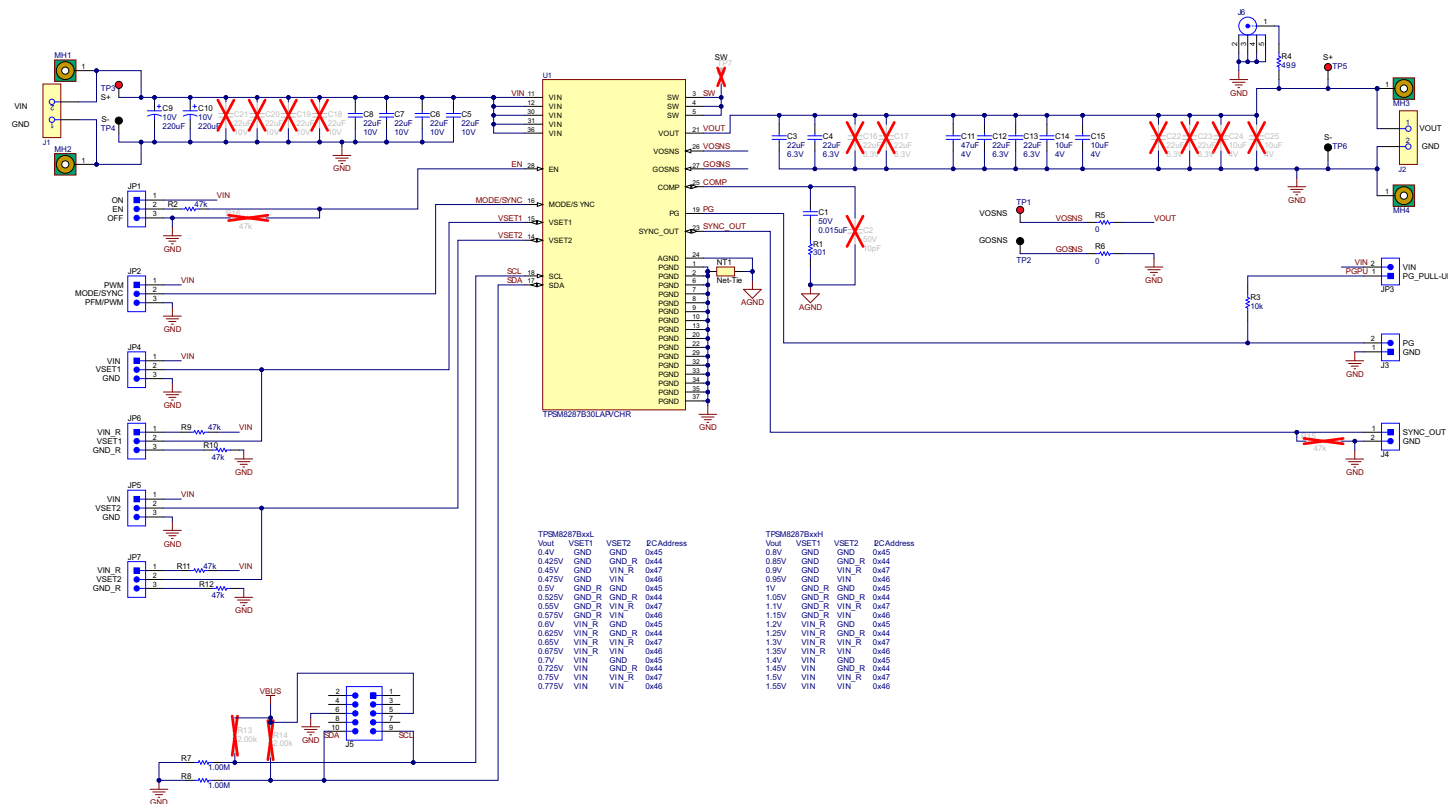


图 5-1. TPSM8287B30LAPEVM 原理图

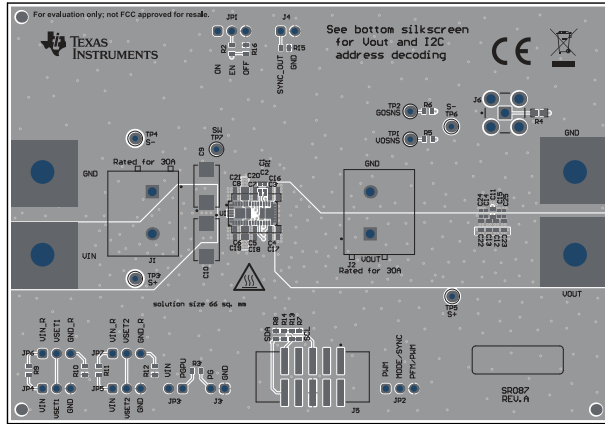


图 5-2. 顶层装配图

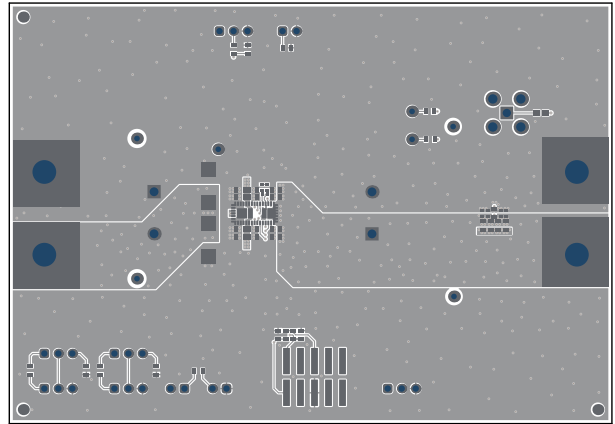


图 5-3. 顶层

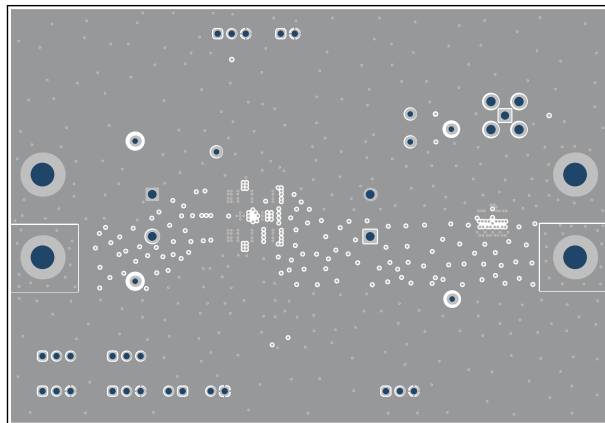


图 5-4. 内层 1

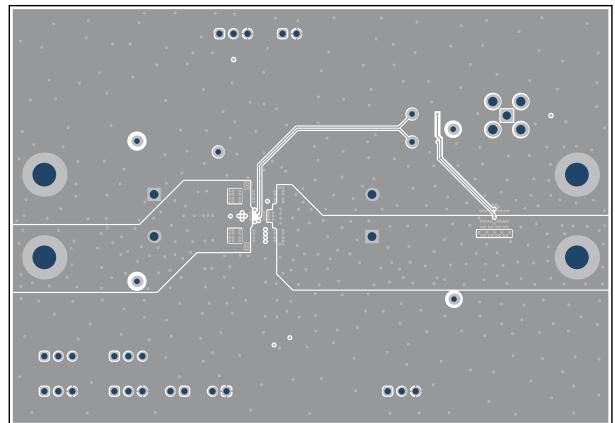


图 5-5. 内层 2

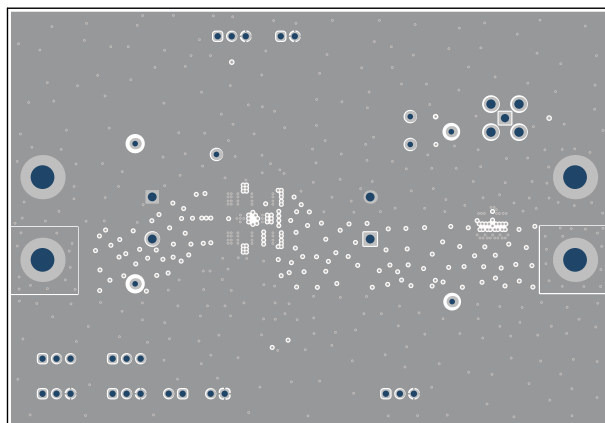


图 5-6. 内层 3

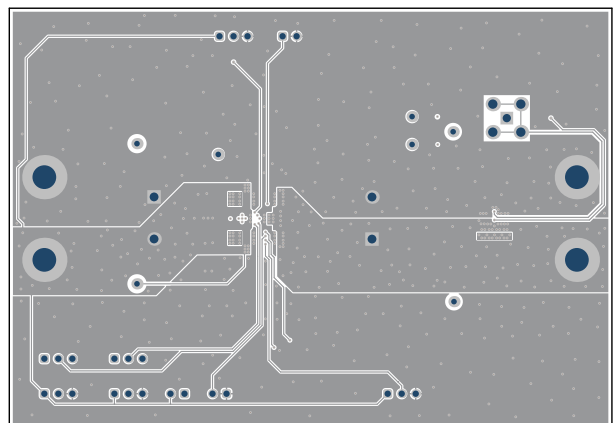


图 5-7. 内层 4

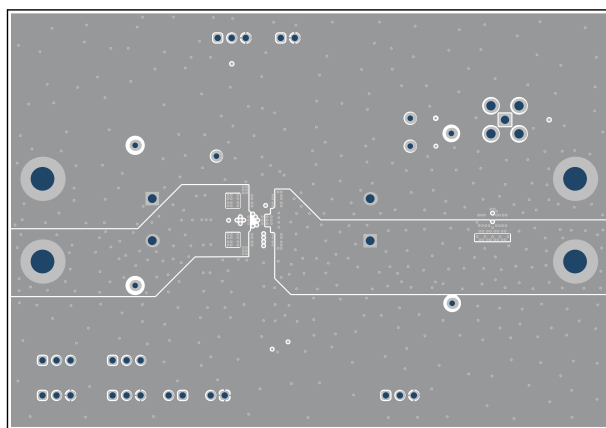


图 5-8. 内层 5

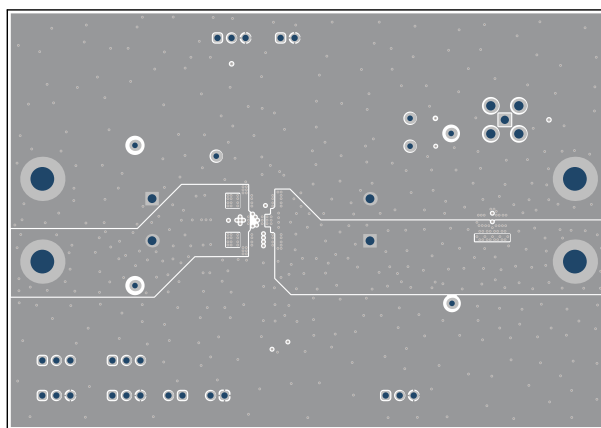


图 5-9. 内层 6

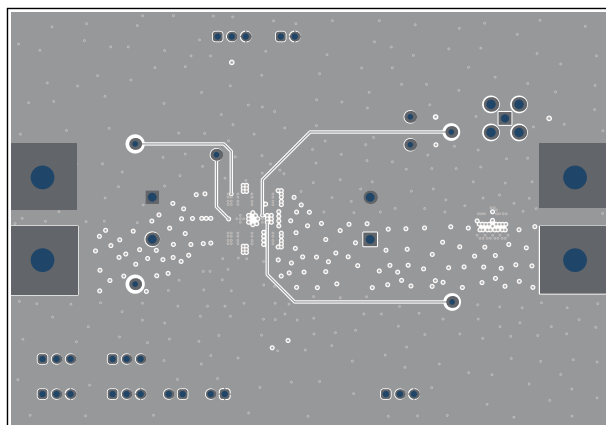


图 5-10. 底层

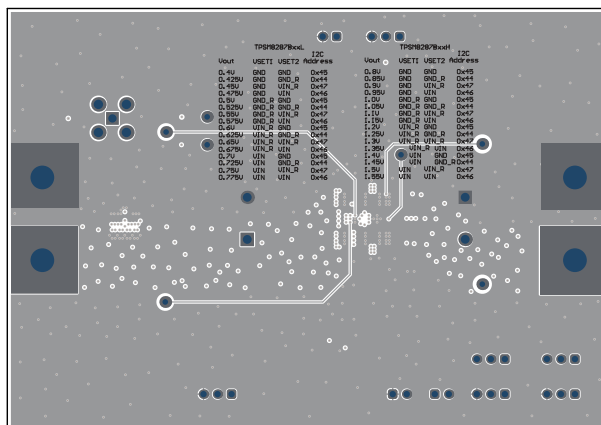


图 5-11. 底层装配 (镜像)
