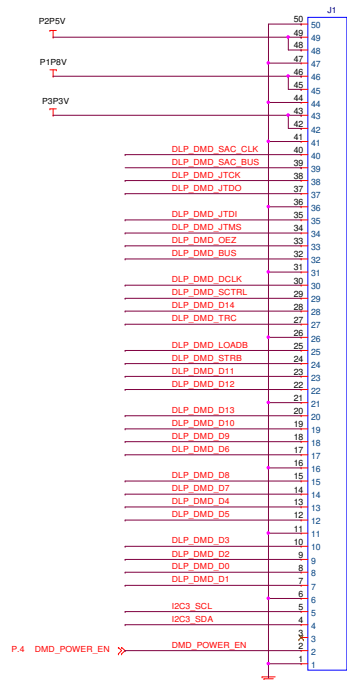

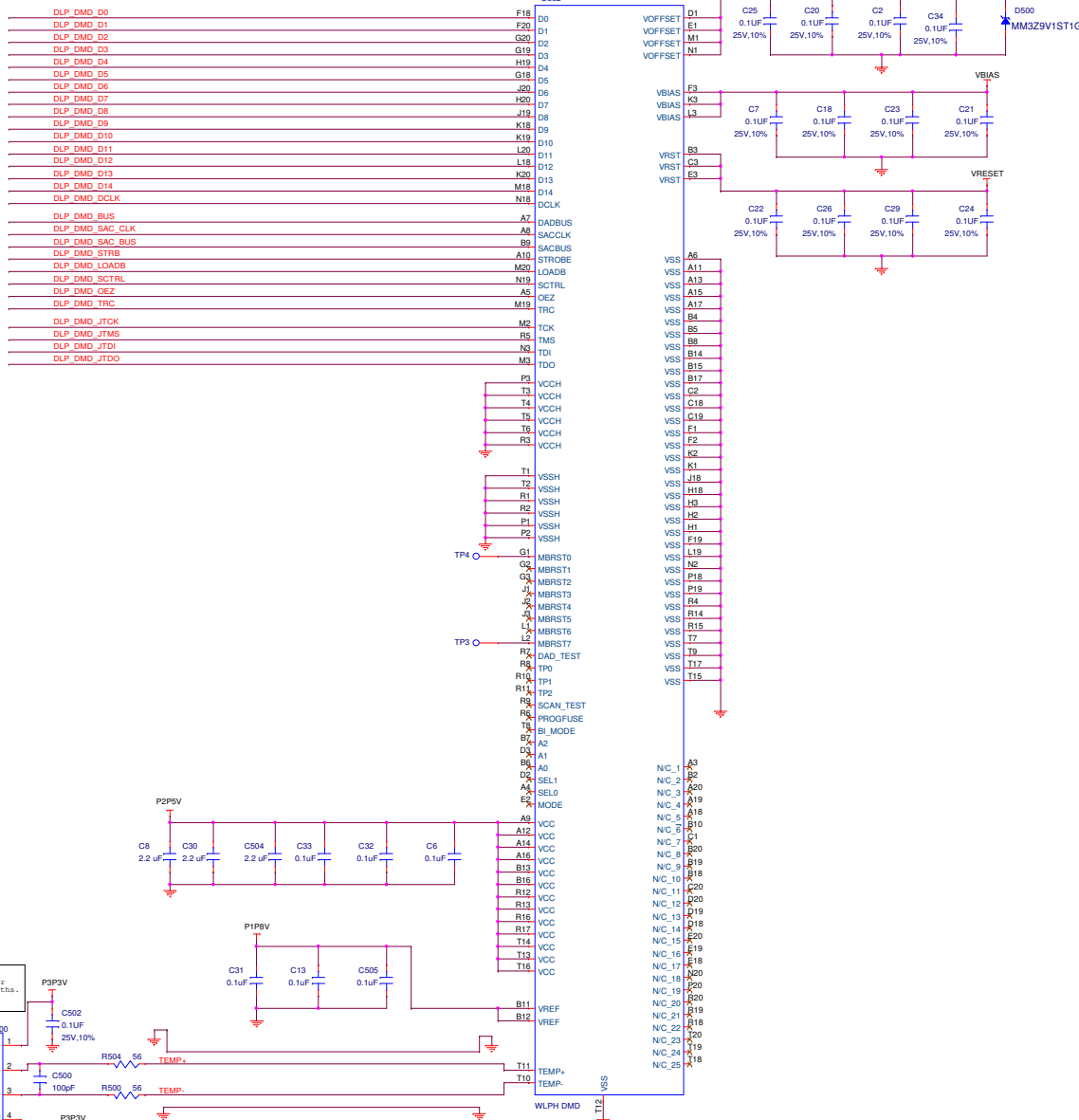
DMD BLOCK DIAGRAM

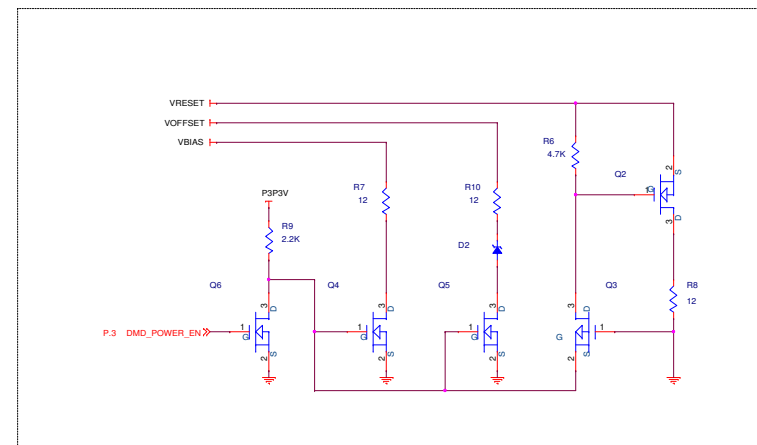
DMD Connector
